**ORDINANCE NO. 2015-O-19**

**AN ORDINANCE PROVIDING FOR THE SUBMISSION TO THE ELECTORS OF THE VILLAGE OF WILLOW SPRINGS, COOK COUNTY, ILLINOIS THE QUESTION WHETHER VIDEO GAMING SHALL BE AUTHORIZED IN THE VILLAGE OF WILLOW SPRINGS**

**WHEREAS**, the Village of Willow Springs, Cook County, Illinois (the *AVillage@*) is a duly organized and existing municipal corporation created under the provisions of the laws of the State of Illinois and under the provisions of the Illinois Municipal Code, as from time to time supplemented and amended; and

**WHEREAS**, the State of Illinois Video Gaming Act (230 ILCS 40/1 et seq.; PA96-0034) became law in July 13, 2009, and allows certain licensed establishments to conduct video gaming; and

**WHEREAS**, the Village Board is desirous of asking the residents of Willow Springs through a binding public question on the March 15, 2016 ballot as to whether video gaming shall be authorized within the Village.

**NOW, THEREFORE, BE IT ORDAINED** by the President and Board of Trustees of the Village of Willow Springs, Cook County, Illinois, as follows:

**Section 1.** That the above recitals and legislative findings are found to be true and correct and are hereby incorporated herein and made a part hereof, as if fully set forth in their entirety.

**Section 2.** The Village Clerk is directed to immediately certify and submit the following question to the Cook County Clerk to be placed on the ballot for the election to be held on March 15, 2016, in the following form:

**Section 3.** If any section, paragraph, clause or provision of this Ordinance shall be held invalid, the invalidity thereof shall not affect any of the other provisions of this Ordinance.

**Section 4.** All ordinances, resolutions, motions or orders in conflict with this Ordinance are hereby repealed to the extent of such conflict.

**Section 5.** This Ordinance shall be in full force and effect immediately upon its passage, approval and publication as provided by law in order to preserve the health, safety and welfare of the residents by ensuring that the electors of the Village are afforded the opportunity to consider the public question herein contained.


