**ORDINANCE NO. 2015-O-03**

**AN ORDINANCE ABATING THE REAL ESTATE TAX HERETOFORE  
LEVIED FOR THE TAX LEVY YEAR 2014 TO PAY THE DEBT  
SERVICE ON \$2,585,000 GENERAL OBLIGATION BONDS  
(ALTERNATE REVENUE SOURCE), SERIES 2004B, OF THE VILLAGE  
OF WILLOW SPRINGS, COOK COUNTY, ILLINOIS**

**WHEREAS**, the Village President and Board of Trustees (the “Corporate Authorities”) of the Village of Willow Springs Cook County, Illinois (the “Village”) by Ordinance adopted on the 9<sup>th</sup> day of December, 2004, being Ordinance No. 29-O-2004 (the “Bond Ordinance”), did provide for the issuance of not to exceed \$2,700,000 General Obligation Refunding Bonds (Alternate Revenue Source), Series 2004B (the “Bonds”) and the levy of a direct annual tax sufficient to pay the debt service on the Bonds; and

**WHEREAS**, the Village has Pledged Revenues (as defined in the Bond Ordinance) in the “Special Tax Allocation Fund - Accounts” referred to in Section 12 of the Bond Ordinance for the purpose of paying the debt service on the Bonds up to and including, December 1, 2015; and

**WHEREAS**, it is necessary and in the best interest of the Village that the tax heretofore levied in the Bond Ordinance for the tax levy year 2014 to pay the debt service on the Bonds be abated.

**NOW, THEREFORE, BE IT ORDAINED** by the Village President and Board of Trustees of the Village of Willow Springs, Cook County, Illinois, as follows:

**SECTION 1:** The above stated preamble paragraphs are incorporated as though fully set forth herein.

**SECTION 2:** **Abatement of Real Estate Tax.** The real estate tax heretofore levied for the year 2014 in the Bond Ordinance is hereby abated in the amount of two hundred eighty five thousand and six hundred and twenty dollars (\$285,620).

**SECTION 3:** **Filing of Ordinance.** Forthwith upon the adoption of this Ordinance No. 2015-O-02, the Village Attorney shall file a certified copy hereof with the County Clerk of Cook County, Illinois, and it shall be the duty of said County Clerk to abate said real estate tax levied under the Bond Ordinance for the tax levy year 2014, in accordance with the provisions hereof.

**SECTION 4: Effective Date, Publication.** That this Ordinance No. 2015-O-02 shall become and be effective immediately upon its passage, approval and publication in the manner provided by law. It is ordered that publication of this Ordinance No. 2015-O-03 be made by duplicating thereof in pamphlet form, said pamphlets to be deposited in the Office of the Village Clerk of the Village of Willow Springs, for general distribution.

**SECTION 5:** That all ordinances in conflict with the provisions hereof are hereby repealed insofar as they conflict herewith.




