**AN ORDINANCE APPROVING AN AGREEMENT FOR INSURANCE

WHEREAS, the Village of Willow Springs has a duty to insure its assets, property and equipment; and

WHEREAS, the Village of Willow Springs has solicited bids for insurance coverage for the Village's assets, property and equipment; and

WHEREAS, the Village of Willow Springs has reviewed the proposals for insurance coverage and have selected the proposal submitted by Connor and Gallagher Insurance, a copy of the proposal submitted by Connor and Gallagher Insurance and accepted by the Village of Willow Springs is attached hereto as Exhibit A.

NOW, THEREFORE, BE IT RESOLVED by the President and Board of Trustees of the Village of Willow Springs, Cook County, Illinois, as follows:

SECTION 1: That the above recitals are incorporated herein and made a part hereof.

SECTION 2: The Village President and Village Clerk are hereby authorized by the Village Board to enter into the Agreement with Connor and Gallagher Insurance.




