AN ORDINANCE APPROVING AND AUTHORIZING
THE PUBLICATION OF THE OFFICIAL ZONING MAP OF
THE VILLAGE OF WILLOW SPRINGS, COOK COUNTY, ILLINOIS

WHEREAS, Section 5/11-13-15 of the Illinois Municipal Code requires the corporate authorities to annually publish by March 31, an official zoning map of the Village showing existing zoning, uses, division, restriction, regulation and classification of the Village of Willow Springs for the proceeding calendar year; and

WHEREAS, the President and Board of Trustees have authorized the Village Engineer to update for publication the Village's official zoning map.

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF WILLOW SPRINGS, COOK COUNTY, ILLINOIS, AS FOLLOWS:

Section 1. Official Zoning Map Approved. The official zoning map of the Village, dated as of March 25, 2010, and prepared by the Village's Engineer, Hoefflerle-Butler Engineering, Inc., a true and accurate copy of which is attached hereto as Exhibit "A" be, and the same is hereby approved, as the updated official zoning map of the Village through March 31, 2011.

Section 2. Publication. Copy Fee.


A. The Village Engineer shall cause copies of the official zoning map to be published by the printing of sufficient copies and the posting of one (1) copy prominently at the Village Hall.

B. Copies of the Official Zoning Map shall be available for purchase in the Village Clerk's Office at a cost of Fifteen and 00/100 Dollars (\$15.00) per copy.
