## ORDINANCE NO. 2011-O-11

### AN ORDINANCE AMENDING TITLE 10 "POLICE REGULATIONS", CHAPTER 1 "GENERAL OFFENSES" OF THE VILLAGE CODE OF THE OF WILLOW SPRINGS, COOK COUNTY, ILLINOIS

**WHEREAS**, the Village of Willow Springs (the "*Village*") is a duly organized and existing municipal corporation created under the provisions of the laws of the State of Illinois and under the provisions of the Illinois Municipal Code, as from time to time supplemented and amended; and

**WHEREAS**, the Village may enact ordinances pursuant their police powers granted to the Village by the Illinois Municipal Code;

**WHEREAS**, President and the Board of Trustees of the Village of Willow Springs (the "Corporate Authorities") designates the police regulations contained in Title 10 "Police Regulations"; and

**WHEREAS**, periodically these regulations need to be adjusted to accommodate the changing needs of the Village and its residents; and

**WHEREAS**, the Corporate Authorities have decided to amend Title 10, Chapter 1, Section 4 to revise the disorderly conduct regulations.

**NOW, THEREFORE, BE IT ORDAINED** BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF WILLOW SPRINGS, COOK COUNTY, ILLINOIS, AS FOLLOWS:

**SECTION 1:** That the above recitals and legislative findings are found to be true and correct and are hereby incorporated herein and made a part hereof, as if fully set forth in their entirety.

**SECTION 2.** Section 4 "Offenses Against the Person" of Chapter 1 "General Offenses" of Title 10 "Police Regulations" is hereby amended by adding subsection G to read as follows

G. Hindering Employees: No person shall interfere with, unreasonably disrupt or delay or in any manner hinder any employee or contractor of the Village while such

employee or contractor is engaged in the performance of his or her duties or constructing, repairing or caring for any Village property.

**SECTION 3:** If any section, paragraph, clause or provision of this ordinance shall be held invalid, the invalidity thereof shall not affect any of the other provisions of this ordinance.


**SECTION 4:** All ordinances or parts of ordinances in conflict herewith are hereby repealed.

**SECTION 5:** This Ordinance shall take effect immediately and be in force from and after its passage and approval due to the urgent nature of this matter.


