ORDINANCE NO. 2011-O-15

AN ORDINANCE AMENDING TITLE 9A "ZONING REGULATIONS", CHAPTER 8 "SIGN REGULATIONS" OF THE VILLAGE CODE OF THE OF WILLOW SPRINGS, COOK COUNTY, ILLINOIS

WHEREAS, the Village of Willow Springs (the "*Village*") is a duly organized and existing municipal corporation created under the provisions of the laws of the State of Illinois and under the provisions of the Illinois Municipal Code, as from time to time supplemented and amended; and

WHEREAS, President and the Board of Trustees of the Village of Willow Springs (the "Corporate Authorities") designates the sign regulations contained in Title 9A "Zoning Regulations"; and

WHEREAS, periodically these regulations need to be adjusted to accommodate the changing needs of the Village and its residents; and

WHEREAS, the Corporate Authorities have decided to amend Title 9A, Chapter 8 to revise the sign regulations.

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF WILLOW SPRINGS, COOK COUNTY, ILLINOIS, AS FOLLOWS:

SECTION 1: That the above recitals and legislative findings are found to be true and correct and are hereby incorporated herein and made a part hereof, as if fully set forth in their entirety.

SECTION 2. Section 3 "General Provisions" of Chapter 8 "Sign Regulations" of Title 9A "Zoning Regulations" is hereby amended by adding subsection M to read as follows

"M. Signs in Public Right of Way: Signs in the public rights of way, which are not public signs, are prohibited."

SECTION 3: If any section, paragraph, clause or provision of this ordinance shall be held invalid, the invalidity thereof shall not affect any of the other provisions of this ordinance.

SECTION 4: All ordinances or parts of ordinances in conflict herewith are hereby repealed.

SECTION 5: This Ordinance shall take effect immediately and be in force from and after its passage and approval due to the urgent nature of this matter.
