ORDINANCE NO. 2011-O-20

AN ORDINANCE AMENDING ORDINANCE 2011-O-10 "AN ORDINANCE ABATING THE REAL ESTATE TAX HERETOFORE LEVIED FOR THE TAX LEVY YEAR 2010 TO PAY THE DEBT SERVICE ON \$880,000 GENERAL OBLIGATION LIMITED TAX BONDS, SERIES 2008B", OF THE VILLAGE OF WILLOW SPRINGS, COOK COUNTY, ILLINOIS

WHEREAS, the Village President and Board of Trustees (the "Corporate Authorities") of the Village of Willow Springs Cook County, Illinois (the "Village") by Ordinance adopted on the 21st day of August, 2008, being Ordinance No. 32-O-2008 (the "Bond Ordinance"), did provide for the issuance of \$880,000 General Limited Tax Bonds (Alternate Revenue Source), Series 2008B (the "Bonds") and the levy of a direct annual tax sufficient to pay the debt service on the Bonds; and

WHEREAS, the Village has sufficient funds available in the "Bond Fund" (as defined in the Bond Ordinance) for the purpose of paying \$100,000.00 of the debt service on the Bonds up to and including, December 1, 2011; and

WHEREAS, it is necessary and in the best interest of the Village that the tax heretofore levied in the Bond Ordinance for the tax levy year 2010 to pay \$100,000.00 of the debt service on the Bonds be abated;

WHEREAS, Section 2 of Ordinance 2011-O-10 must be amended in order to accurately describe that only \$100,000 of the debt service on the Bonds are to be abated.

NOW, THEREFORE, BE IT ORDAINED by the Village President and Board of Trustees of the Village of Willow Springs, Cook County, Illinois, as follows:

SECTION 1: The above stated preamble paragraphs are incorporated as though fully set forth herein.

SECTION 2: **Abatement of Real Estate Tax.** The real estate tax heretofore levied for the year 2010 in the Bond Ordinance is hereby abated in the amount of one hundred thousand dollars (\$100,000).

SECTION 3: **Filing of Ordinance.** Forthwith upon the adoption of this Ordinance No. 2011-O-20, an ordinance amending Ordinance No. 2011-O-10, the Village Attorney shall file a certified copy hereof with the County Clerk of Cook County, Illinois, and it shall be the duty of said County Clerk to abate by \$100,000 said real estate tax levied under the Bond Ordinance for the tax levy year 2010, in accordance with the provisions hereof.




**TRUTH IN TAXATION
