**ORDINANCE NO. 2012-O-12**

**AN ORDINANCE ABATING THE REAL ESTATE TAX HERETOFORE  
LEVIED FOR THE TAX LEVY YEAR 2011 TO PAY THE DEBT SERVICE  
ON \$1,100,000 GENERAL OBLIGATION BONDS (ALTERNATE  
REVENUE SOURCE), SERIES 2012A, OF THE VILLAGE OF WILLOW  
SPRINGS, COOK COUNTY, ILLINOIS**

**WHEREAS**, the Village President and Board of Trustees (the "Corporate Authorities") of the Village of Willow Springs Cook County, Illinois (the "Village") by Ordinance adopted on the 23<sup>rd</sup> day of February, 2012, being Ordinance No. 2012-O-03 (the "Bond Ordinance"), did provide for the issuance of \$1,100,000 General Obligation Bonds (Alternate Revenue Source), Series 2012A (the "Bonds") and the levy of a direct annual tax sufficient to pay the debt service on the Bonds; and

**WHEREAS**, the Village has pledged LTB Proceeds (as defined in the Bond Ordinance) in the "Alternate Bond Fund" referred to in Section 12 of the Bond Ordinance for the purpose of paying the debt service on the Bonds up to and including, December 1, 2012; and

**WHEREAS**, it is necessary and in the best interest of the Village that a portion of the tax heretofore levied in the Bond Ordinance for the tax levy year 2011 to pay the debt service on the Bonds be abated.

**NOW, THEREFORE, BE IT ORDAINED** by the Village President and Board of Trustees of the Village of Willow Springs, Cook County, Illinois, as follows:

**SECTION 1:** The above stated preamble paragraphs are incorporated as though fully set forth herein.

**SECTION 2:** **Abatement of Real Estate Tax.** The real estate tax heretofore levied for the year 2011 in the Bond Ordinance is hereby abated in its entirety.

**SECTION 3:** **Filing of Ordinance.** Forthwith upon the adoption of this Ordinance No 2012-O-\_\_\_, the Village Attorney shall file a certified copy hereof with the County Clerk of Cook County, Illinois, and it shall be the duty of said County Clerk to abate said real estate tax levied under the Bond Ordinance for the tax levy year 2011, in accordance with the provisions hereof.




