ORDINANCE NO. 2014-O-02

**AN ORDINANCE AMENDING SECTION 11-6-5 OF THE VILLAGE CODE OF THE
VILLAGE OF WILLOW SPRINGS, COOK COUNTY, ILLINOIS**

WHEREAS, the Village of Willow Springs, Cook County, Illinois (the *AVillage@*) is a duly organized and existing municipal corporation created under the provisions of the laws of the State of Illinois and under the provisions of the Illinois Municipal Code, as from time to time supplemented and amended; and

WHEREAS, the State of Illinois, Department of Transportation, is desirous of improving the FAU Route 3565, Route 171 at 104th Avenue/Willow Springs Road; and

WHEREAS, said project includes the widening, overlay of PCC, resurfacing and traffic signal installation as well as installation of storm sewers and drainage facilities; and

WHEREAS, in order to facilitate the free flow of traffic and ensure the safety of the citizenry, parking along the improvement area shall be prohibited.

NOW, THEREFORE, BE IT ORDAINED by the President and Board of Trustees of the Village of Willow Springs, Cook County, Illinois as follows:

Section 1. That the above recitals and legislative findings are found to be true and correct and are hereby incorporated herein and made a part hereof, as if fully set forth in their entirety.

Section 2. Section 11-6-5(D) of the Village Code of the Village of Willow Springs is hereby amended by deleting the following language to read, as follows:

D. Parking Restriction, Street Improvement:

1. It shall be unlawful for any person to park a vehicle, or cause to have a vehicle parked, on or along Illinois Route 171 (Archer Avenue) ~~from Wentworth Avenue to U.S. Route 45~~ except

where permitted where signs have been posted or other street markings have been made giving notice thereof. Where parking is so permitted, the parking shall be parallel only.

Section 3. The Village Clerk of the Village of Willow Springs is authorized and directed to attach a copy of this Ordinance to the agreement dated Feb. 13, 2014 by and between the State of Illinois and the Village of Willow Springs relative to the improvement.

Section 4. If any section, paragraph, clause or provision of this Ordinance shall be held invalid, the invalidity thereof shall not affect any of the other provisions of this Ordinance.


Section 5. All ordinances, resolutions, motions or orders in conflict with this Ordinance are hereby repealed to the extent of such conflict.

Section 6. This Ordinance shall be in full force and effect upon its passage, approval and publication as provided by law.






