ORDINANCE NO. 2017-O-12

AN ORDINANCE ABATING THE REAL ESTATE TAX HERETOFORE LEVIED FOR THE TAX LEVY YEAR 2016 TO PAY THE DEBT SERVICE ON \$1,220,000 GENERAL OBLIGATION BONDS (ALTERNATE REVENUE SOURCE), SERIES 2008C, OF THE VILLAGE OF WILLOW SPRINGS, COOK COUNTY, ILLINOIS

WHEREAS, the Village President and Board of Trustees (the “Corporate Authorities”) of the Village of Willow Springs Cook County, Illinois (the “Village”) by Ordinance adopted on the 21st day of August, 2008, being Ordinance No. 33-O-2008 (the “Bond Ordinance”), did provide for the issuance of \$1,220,000, General Limited Tax Bonds (Alternate Revenue Source), Series 2008C (the “Bonds”) and the levy of a direct annual tax sufficient to pay the debt service on the Bonds; and

WHEREAS, the Village has Pledged Revenues in the “2008C Bond and Interest Fund” (as defined in the Bond Ordinance) referred to in Section 11 of the Bond Ordinance for the purpose of paying the debt service on the Bonds up to and including, December 1, 2017; and

WHEREAS, it is necessary and in the best interest of the Village that the tax heretofore levied in the Bond Ordinance for the tax levy year 2016 to the debt service on the Bonds be abated.

NOW, THEREFORE, BE IT ORDAINED by the Village President and Board of Trustees of the Village of Willow Springs, Cook County, Illinois, as follows:

SECTION 1: That the above recitals and legislative findings are found to be true and correct and are hereby incorporated herein and made a part hereof, as if fully set forth in their entirety

SECTION 2: **Abatement of Real Estate Tax.** The real estate tax heretofore levied for the year 2016 in the Bond Ordinance is hereby abated in its entirety.

SECTION 3: **Filing of Ordinance.** Forthwith upon the adoption of this Ordinance No. 2017-O-12, the Village Attorney shall file a certified copy hereof with the County Clerk of Cook County, Illinois, and it shall be the duty of said County Clerk to abate said real estate tax levied under the Bond Ordinance for the tax levy year 2016, in accordance with the provisions hereof.


SECTION 4: **Effective Date, Publication.** That this Ordinance No. 2017-O-12 shall become and be effective immediately upon its passage, approval and publication in the manner provided by law. It is ordered that publication of this Ordinance No. 2017-O-12 be made by duplicating thereof in pamphlet form, said pamphlets to be deposited in the Office of the Village Clerk of the Village of Willow Springs, for general distribution.

SECTION 5: That all ordinances in conflict with the provisions hereof are hereby repealed insofar as they conflict herewith.


