**AN ORDINANCE AMENDING TITLE 3 “BOARDS AND COMMISSIONS” OF THE
VILLAGE CODE OF THE VILLAGE OF WILLOW SPRINGS, COOK COUNTY,
ILLINOIS
(FOREIGN FIRE INSURANCE BOARD ABOLISHMENT)**

WHEREAS, the Village of Willow Springs, Cook County, Illinois (the *AVillage@*) is a duly organized and existing municipal corporation created under the provisions of the laws of the State of Illinois and under the provisions of the Illinois Municipal Code, as from time to time supplemented and amended; and

WHEREAS, President and the Board of Trustees of the Village of Willow Springs (the “*Corporate Authorities*”) designates the boards and commissions for the Village contained in Title 3; and

WHEREAS, pursuant to 65 ILCS 5/11-10, et seq., the Village established a Foreign Fire Insurance Board to collect and manage fees paid by foreign fire insurance companies on the sale of fire insurance on properties located in the Village; and

WHEREAS, periodically the Village Code needs to be adjusted to accommodate the changing needs of the Village and its residents; and

WHEREAS, pursuant to the March 15, 2016 election the voters of the Village voted in favor of joining the Tri-State Fire Protection District (“*District*”) and the District accepted the additional territory of the Village into the corporate limits of the District at its April 11, 2016 special meeting of the Board of Trustees; and

WHEREAS, the Village no longer employs a Municipal Fire Department hereby deeming the establishment of the Foreign Fire Insurance Board of the Village unnecessary; and

WHEREAS, the Corporate Authorities have decided to amend the Village Code to abolish the Foreign Fire Insurance Board.

NOW, THEREFORE, BE IT ORDAINED by the President and Board of Trustees of the Village of Willow Springs, Cook County, Illinois as follows:

Section 1. That the above recitals and legislative findings are found to be true and correct and are hereby incorporated herein and made a part hereof, as if fully set forth in their entirety.

Section 2. Title 3 “Boards and Commissions” is hereby amended by deleting Chapter 8 “Foreign Fire Insurance Board” in its entirety.

Section 3. Any funds said on hand collected from Foreign Fire Insurance companies in accordance with said Chapter 8 of the Village Code shall be transferred by the Village Treasurer to the Tri-State Fire Protection District.

Section 4. If any section, paragraph, clause or provision of this Ordinance shall be held invalid, the invalidity thereof shall not affect any of the other provisions of this Ordinance.

Section 5. All ordinances, resolutions, motions or orders in conflict with this Ordinance are hereby repealed to the extent of such conflict.

Section 6. This Ordinance shall be in full force and effect immediately upon its passage, approval in light of the urgent and nature of this matter.




