AN ORDINANCE AMENDING TITLE 8, CHAPTER 1, SECTION 8 OF THE
WILLOW SPRINGS MUNICIPAL ADOPTING THE ILLINOIS PLUMBING CODE

BE IT ORDAINED BY THE PRESIDENT AND VILLAGE BOARD OF THE VILLAGE OF
WILLOW SPRINGS, ILLINOIS, AS FOLLOWS:

SECTION 1: The following changes are made to Section 8-1-8 of the Willow Springs Municipal Code (additions underlined and deletions noted with strikethrough text):

8-1-8: ~~ADOPTION OF INTERNATIONAL PLUMBING CODE AND STATE OF ILLINOIS PLUMBING CODE:~~

~~There is hereby adopted by reference by the village for the purpose of prescribing regulations for the control of buildings and structures those certain codes known as the international plumbing code, 2003 edition, including appendix chapters A, B, C, D, E, F and G, as published by the International Code Council, Inc., as if fully set forth in this chapter with the additions, insertions, deletions and changes, if any, heretofore adopted and the most recent edition of the state of Illinois plumbing code. In the event of any conflict between the two (2) codes, the more restrictive regulation shall apply. The 2014 state of Illinois plumbing code is hereby adopted, with all subsequent editions and amendments hereafter, by reference as if fully set out herein.~~

SECTION 2: This Ordinance shall not be held to repeal a former ordinance as to any offense committed against the former ordinance or as to any act done, any penalty, forfeiture or punishment so incurred, or any right accrued or claim arising under the former ordinance, or in any way whatsoever affect any such offense or act so committed or so done, or any penalty, forfeiture or punishment so incurred to any right accrued to claims arising before this Ordinance takes effect, save only that the proceedings thereafter shall conform to the ordinance in force at the time of such proceedings, as far as practicable.

SECTION 3: That if any part or parts of this Ordinance shall be held to be invalid or unconstitutional by a court of competent jurisdiction, such invalidity or unconstitutionality shall not affect the validity of the remaining parts of this Ordinance. The Village Board declare hereby that they would have passed the

remaining parts of this Ordinance, if they had known that such part or parts thereof would be declared unconstitutional.

SECTION 4: The Village Clerk of the Village of Willow Springs is directed hereby to publish this Ordinance in pamphlet form.

SECTION 5: This ordinance shall be in full force and effect from and after its passage, approval, and publication in pamphlet form.




