

ORDINANCE NO. 2018-O-19

AN ORDINANCE ABATING THE 2017 THROUGH 2027 TAX LEVIES FOR DEBT SERVICE ON THE \$1,520,000 GENERAL OBLIGATION BONDS (ALTERNATE REVENUE SOURCE), SERIES 2008A OF THE VILLAGE OF WILLOW SPRINGS, COOK COUNTY, ILLINOIS

BE IT ORDAINED by the Village President and Board of Trustees of the Village of Willow Springs, Cook County, Illinois, as follows:

Section 1

Pursuant to the provisions of Ordinance No. 31-O-2008, the tax levied for the \$1,520,000 General Obligation Bonds (Alternate Revenue Source), Series 2008A, is hereby abated as follows:

Section 3


All ordinances or parts of ordinances in conflict with the provisions of this ordinance are hereby repealed insofar as they conflict herewith.

Section 4


This ordinance shall be immediately in full force and effect upon its passage and approval.
