**ORDINANCE 2019-O-35**

**DELIVERY OF ALCOHOL IN CONJUNCTION WITH FOOD DELIVERY**

**BE IT ORDAINED BY THE VILLAGE BOARD OF THE VILLAGE OF WILLOW SPRINGS, ILLINOIS:**

**SECTION 1:** That, Section 4-3-25(E) of Chapter 3 of Title 4 of the Village of Willow Springs Code is hereby amended; and shall be and read as follows:

**4-3-25:PROHIBITED TRANSACTIONS AND MISCELLANEOUS REGULATIONS FOR LICENSED PREMISES**

~~E. Transactions Confined To Licensed Premises; Peddling Prohibited: All sales shall be transacted on the licensed premises and the delivery of alcoholic liquor shall be made to the purchaser on the licensed premises. It shall be unlawful to peddle or deliver alcoholic liquor in the village. Delivery of alcoholic liquor shall only be permitted pursuant to state law.~~

**E. Transactions Confined To Licensed Premises; Peddling Prohibited:** It shall be unlawful to peddle alcoholic liquor in the Village. Delivery of alcoholic liquor shall only be permitted pursuant to state law and in accordance with the following requirements:

Only those establishments which hold a valid Village of Willow Springs Liquor License and a valid Village of Willow Springs Food Service Establishment License shall be permitted to transport, deliver and furnish alcoholic liquor in its original package from the licensee so long as 1) delivery of alcohol is in conjunction with the delivery of food prepared by the food service establishment; 2) orders are placed by telephone, facsimile, electronic mail, or the internet; 3) is with restricted delivery to a customer only upon proof presented by the customer that such customer is twenty one (21) years of age or older; 4) processed with a shipping container that is clearly labeled to indicate that the package cannot be delivered to a person under the age of twenty one (21) years; 5) is for consumption on the customer's premises and not for resale; and 6) that no sale of or order for alcoholic liquor be accepted between the hours of 1 A.M and 12 P.M..

**SECTION 2:** This Ordinance shall not be held to repeal a former ordinance as to any offense committed against the former ordinance or as to any act done, any penalty, forfeiture or punishment so incurred, or any right accrued or claim arising under the former ordinance, or in any way whatsoever affect any such offense or act so committed or so done, or any penalty, forfeiture or punishment so incurred to any right accrued to claims arising before this Ordinance

takes effect, save only that the proceedings thereafter shall conform to the ordinance in force at the time of such proceedings, as far as practicable.

**SECTION 3:** That if any part or parts of this Ordinance shall be held to be invalid or unconstitutional by a court of competent jurisdiction, such invalidity or unconstitutionality shall not affect the validity of the remaining parts of this Ordinance. The Village Board declare hereby that they would have passed the remaining parts of this Ordinance, if they had known that such part or parts thereof would be declared unconstitutional.


**SECTION 4:** The Village Clerk of the Village of Willow Springs is directed hereby to publish this Ordinance in pamphlet form.

**SECTION 5:** This ordinance shall be in full force and effect from and after its passage, approval, and publication in pamphlet form.


