**ORDINANCE 2020-O-01**

**CORRECTING A SCRIVNER’S ERROR CONTAINED IN ORDINANCE 2019-O-38**

**WHEREAS**, the President and Village Board approved and adopted Ordinance 2019-O-38 entitled: “An Ordinance of the Village of Willow Springs, Cook County, Illinois Authorizing and Approving an Agreement for Residential Collection and Transpiration of Municipal Solid Waste by and Between the Village of Willow Springs and Roy Strom Refuse Removal Service, Inc.” on December 12, 2019;

**WHEREAS**, Ordinance 2019-O-38 contained a scrivener’s error in that the Ordinance Number had previously been designated to a prior ordinance;

**WHEREAS**, this Ordinance is only intended to the correct a scrivener’s error as described above, and this Ordinance does not change or modify Ordinance 2019-O-38 except as expressly provided herein;

**NOW THEREFORE, BE IT ORDAINED**, by the Village Board of the Village of Willow Springs, Cook County, Illinois, as follows:

**SECTION 1:** That the foregoing Findings and Recitals are hereby adopted and incorporated herein by reference, as though the same were fully set forth herein.

**SECTION 2:** That the number of Ordinance 2019-O-38 entitled: “An Ordinance of the Village of Willow Springs, Cook County, Illinois Authorizing and Approving an Agreement for Residential Collection and Transpiration of Municipal Solid Waste by and Between the Village of Willow Springs and Roy Strom Refuse Removal Service, Inc.” approved on December 12, 2019 is hereby amended to Ordinance Number 2019-O-42.

**SECTION 3:** This Ordinance does not supersede or repeal Ordinance 2019-O-38 as described herein, and the Ordinance shall remain in full force and effect as Ordinance Number 2019-O-42.

**SECTION 4:** The Village Clerk of the Village of Willow Springs is directed hereby to publish this Ordinance in pamphlet form.

**SECTION 5:** This ordinance shall be in full force and effect from and after its passage, approval, and publication in pamphlet form.


