
Freedom of Information Act Section 4 Disclosure

The Village of Willow Springs is a municipal corporation formed under 65 ILCS 5/1-1-3. The purpose of the Village is to provide for the health, welfare and safety of the public. This is accomplished through providing public safety in the form of police protection and fire protection; sewer systems; roads and bridges; community development; zoning and building regulations; health regulations and all other duties as required by law.

The Village is divided into the following functional subdivisions:



The Total operating budget of the Village is \$9,215,080 for the fiscal year 2021.
